Chief Bertram advised the Board that the District was currently waiting on the building permit and the signed final contract documents. Discussion followed.

• Consider Adoption of MOU for Establishment of a Fire Authority President Thorp addressed the Board to make clear the purpose of the MOU and how an MOU operates. The Board discussed amending the MOU to state Chief Bertram's hours not to exceed 8 hours a month. Any additional hours will be billed at \$200.00 per hour, that the Board also discussed making the Mechanic and Inspector available at the discretion of Chief Bertram and inviting Buena Vista Fire Department's firefighters to join in the District's trainings. Further discussion followed.

President Thorp moved to approve the MOU as amended to limit Chief Bertram's hours per month to 8 hours, with any additional hours to be billed at \$200.00 per hour (not to include participation in the steering committee), use of other paid staff at Chief Bertram's discretion, and the open invitation for Buena Vista Fire Department's firefighter to participate in any District trainings. Vice-President Brown seconded. Motion carried unanimously.

President Thorp moved to nominate Director Leonard and Director Navarrette to participate in the steering committee. Vice-President Brown seconded. Motion carried unanimously.
